#### **PUBLIC PARTICIPATION**

Bertha Durante, Robinson Tower- my concern is the security on the desk, the residents working there, I feel we need regular security people, and there seems to be different people working the desk, and there are people working there who are combative with residents. Also mail, the delivery here, we don't when it is coming, or if it's coming, I have received my diabetic medicines here, cell phones that have gone missing and it costs me money out of my pocket. And the cleanliness of the building is disgusting. I also smell smoke and weed in my apartment.

Commissioner Troppoli- do you notice security is lacking at certain time over others?

Bertha Durante- I feel it's bad all the time, people on the desk in the morning, the young lady there now is there often, but a lot of times you come in and no one is manning the desk. And the doors, sometimes they don't open or close.

Valerie Williams, Robinson Tower- I had an incident last weekend, I had two men come up behind me and try to get in, I got into the building quick and got up the elevators as quickly as possible.

Johnny Westbrook- you only have two security people working here. I work all the time, I'm here night and day. I don't get paid for all that time, I only get paid for 4-8 hours a week, Long Branch or whoever won't pay you to work more, but I'm here around the clock, we need more help.

Natalie Turner- we added one new security guard, but that person replaced someone who had to go. We have two more coming on.

Johnny Westbrook- we have people in and out all night on the 4th floor.

Chairman Hopson- we have taken a petition of 28 names, and we've been in touch with the police to try and find out how many calls we've gotten for that unit. There is a process we have to go through and we're trying to resolve the issue.

Bertha Durante- what is the purpose of the job of people working security on the desk, are they allowed to question visitors, or do they have other avenues to address these issues with visitors?

Joseph Mitco, Robinson Tower- I was the one who wrote the letter about what is going on on the 4<sup>th</sup> floor, I have called the police at least 4 or 5 times, the noise got so loud in the apartment next to me. They start at 11 at night and go until 5 in the morning. They argue all night. I've seen people come up and down those back steps, they leave the door open so no one has to come to the front desk. I left my apartment, went over and banged on the door and said "Do I need to call the police or are you going to calm down?" They quieted down. I had a young girl knock on my door late in the evening, and said, "Oh I made a mistake I'm looking for 402." We have a right in this building to contentment and peace and quiet. I like being here, I like the people in this building. You are all kind and friendly and helpful, except for some.

Bertha Durante- the noise he's talking about, I get that too, I have noise below me and above me. I go down and ask them to turn it down, once and while, and it happens a lot on the weekends when no one is working the front or in the office.

Commissioner Torre- that \$75 thousand dollars, that was the misappropriated funds, and they're just questioning how we disbursed that.

Thomas Sahlin- yes and we agreed to pay that back over a course of a few years. They understand we didn't do anything wrong, but we have to take it from the right pot of money.

Commissioner Troppoli- so the other two related resolutions, that's all essentially addressing the same concerns?

Thomas Sahlin- yes.

Commissioner Troppoli- are we going to expect to see more of these in reference to that in the future?

Thomas Sahlin- no, we still have to sit down with HUD and have our final meeting, but we shouldn't have much more changes.
